For example, its head cutters for salmon and trout and fillet machines for accurate center cuts are highly regarded internationally for their outstanding performance and durability. Furthermore, products utilizing proprietary technology, such as the Aqua Cooker, are designed to comply with international hygiene management standards like HACCP and ISO, thereby achieving both improved hygiene and increased operational productivity in food processing environments.

While maintaining a solid market share in key marine processing regions within Japan, particularly Hokkaido, Taiyo Seisakusho is also actively pursuing expansion in international markets. The company boasts extensive transaction history with countries including Russia, Central Asia, and others.
