Dynasafe is a global market leader specializing in the management and disposal of Unexploded Ordnance (UXO), Chemical, Biological, Radiological, Nuclear, and Explosive (CBRNe) materials. Headquartered in Karlskoga, Sweden, the company has dedicated over 30 years to neutralizing the remnants of war and modern explosive threats to safeguard people, property, and the environment.

What sets Dynasafe apart in the defense and security industry is its unique ability to address the entire ordnance disposal value chain. The company operates through three specialized business units, ensuring a comprehensive approach to complex security challenges:

First, **Area Clearance** provides expert services for the survey, detection, and removal of UXO and landmines, both on land and in marine environments. This unit is vital for offshore energy projects, port expansions, and post-conflict redevelopment, where safety is the prerequisite for progress. Second, **Protection Systems** designs and manufactures world-class explosive containment chambers. These gas-tight vessels, such as the DynaSEALR series, allow first responders, police forces, and military units to safely contain and transport suspected bombs or hazardous devices in public spaces like airports and arenas. Third, **Demil Systems** focuses on the safe and environmentally friendly destruction of conventional and chemical munitions. By utilizing proprietary Off-Gas Treatment (OGT) technologies, Dynasafe's plants achieve near-total elimination of toxic emissions, meeting the world's most stringent environmental regulations.

Since its inception, with roots dating back to the early 1990s through entities like Dynasafe BACTEC, the company has successfully completed over 1,000 projects in more than 70 countries. Their track record includes high-stakes missions such as the destruction of chemical weapon stockpiles in various nations and providing security for major global events.

In 2023, the company reached a significant milestone when its CEO, Charles "Charlie" Diggs, acquired the group, reinforcing its commitment to long-term innovation and customer-centric service. Today, Dynasafe continues to evolve as a technology-driven organization with a workforce of approximately 400 dedicated specialists.
