#### Key Responsibilities and Working Relationships

- Drive process optimization and risk mitigation strategies.
- Prepare for and support subsequent product launches.
- Collaborate with Quality Regulatory and Finance teams to ensure smooth operations.

  - Liaise with global teams to align supply chain processes and address operational issues.
