This role involves site inspections, quality documentation, coordination with consultants and contractors, and supporting project teams to achieve quality objectives.

- Review and verify method statements, technical submissions, shop drawings, and material submittals.

- Manage non-conformance reports (NCR), corrective actions, and preventive measures.
- Maintain proper QAQC documentation and records, including inspection reports, test results, and handover documents.
- Support audits (internal / client / regulatory) and ensure continuous improvement of quality processes.
- Assist in final inspections, snagging, and project handover activities.
