1. MS/IATF 16949 Quality System Management:

- Develop, maintain, and improve the quality management system in accordance with IATF 16949 standards and relevant customer/OEM requirements.
- Plan, organize, and monitor internal audits, process audits, system audits, and preparation activities for external audits.

- Ensure that quality documentation, procedures, forms, control standards, and quality records are updated, controlled, and consistently applied throughout the plant.

2. Implementation and control of automotive quality tools:

- Apply, provide guidance on, and oversee the implementation of APQP, Control Plans, FMEA, MSA, SPC, and PPAP during product development, trial production, and mass production stages.
- Evaluate the compliance of relevant departments regarding quality control plans, inspection standards, and specific customer requirements.

- Represent the Quality Department in communications, explanations, and negotiations with customers, particularly OEM or Tier 1 clients in the automotive industry.

- Assess supplier quality capabilities, monitor quality performance, and request improvements when defects arise regarding materials, components, or supplier processes.
- Guide suppliers in conducting failure analysis and implementing corrective actions, 8D reporting, and measures to prevent recurrence.
