- Ensure all works have adequate risk management actions such as risk assessments and method statements.

#### 【Training and Awareness】

- Develop and deliver HSSE training programs for project personnel contractors and subcontractors to promote a strong safety culture and enhance HSSE awareness.
- Develop and execute a meeting cadence focused around embedding HSSE within the project organisation contractors and relevant industry partners.
- Ensure adherence to Life Saving Rules or contractor equivalent is implemented and tracked.

#### 【Investigation and Reporting】

- Lead investigations into HSSE incidents near misses and accidents to identify root causes and implement corrective actions to prevent recurrence.
- Prepare and submit timely and accurate HSSE reports to project stakeholders regulatory authorities and senior management.
- Ensure reporting against specified KPI's and deliver to leadership group with proposed improvement activities against gaps.

#### 【Stakeholder Engagement】

- Foster positive relationships with project stakeholders including sponsors contractors regulatory agencies local communities to promote transparency and collaboration on HSSE matters.
- Represent the company in HSSE related meetings forums and industry associations to share knowledge and best practices.
