- Ensure reporting against specified KPI's and deliver to Project HSSE Manager with proposed improvement activities against gaps.

- Foster positive relationships with contractors to promote transparency and collaboration on HSSE culture and deliverables.
- Represent JNbp within contractor safety meetings forums and kick off meetings.
