- Work closely with the Global Certification and Compliance Lead on certification requirements
- Coordinate certification activities between local operations and global certification teams
- Assist in preparing documentation and processes required for certification
- Ensure readiness for certification audits and ongoing compliance requirements

○Safety Management

- Map and track all applicable safety related legal requirements
- Maintain up to date safety documentation and procedures
- Develop contingency and emergency response plans
- Support implementation of safety systems and compliance programs
- Prepare required reports records and procedures to ensure safe operations
- Conduct regular reviews of site safety compliance
- Establish and maintain safety inspection routines
- Monitor compliance with Japanese occupational health and safety regulations
- Support continuous improvement of site safety practices
