- Conduct periodic PFMEA reviews and updates based on engineering changes, new molds, materials, customer requirements, or process modifications.
- Train production personnel and supervisors on PFMEA methodology, process discipline, and risk-based thinking.
- Ensure compliance with customer-specific requirements (CSR), automotive quality standards, and organizational procedures.
